

PARENT'S RULES & REGULATIONS CONTRACT

- I hereby give permission for my son to join Black Widows Baseball Club (hereafter BWBBC) and I agree to pay the Registration Fee, Uniform Fee, and all monthly fees on time and in accordance to the Fee schedule included with this document.
- I understand that all fees, once paid, are not refundable in the event my child leaves the organization prior to the end of the season.
- I have completed a release form that makes BWBBC and its representatives, paid or volunteer, not liable for injuries to my child.
- I fully understand the financial obligation required for participation in the BWBBC program and I agree to pay all fees on or before the 1st day of the month, and that if payment is not received by the 5th day of the month, I will be obligated to pay a \$25 late payment fee in addition to the monthly fee.
- I further understand that the cancellation of events may occur at the sole discretion of BWBBC, and there will be no refund or pro-ration of fees in the event of such cancellations.
- I understand that my son may be transferred to a different team, be suspended from a team, or removed from the BWBBC organization permanently, at the sole discretion of BWBBC at any time with or without advance notice.
- BWBBC reserves the exclusive right to determine player eligibility and/or spectators to participate in its programs.
- I understand that if my account becomes more than 30 days past due, my child may be dismissed from the team and that BWBBC may forward my account to a collection agency or file a claim against me in small claims court in an attempt to recover the delinquent fees plus any and all third-party fees incurred during the collection of said balance.
- I understand that in the event I decide to voluntarily terminate my child's association with the BWBBC, that I will be financially obligated to pay the current month's dues PLUS one additional month's fees.
- I understand my child may have to sacrifice recreational activities which conflict with tournaments and/or other practices.
- I give Black Widows Baseball Club permission to release my phone numbers and/or address to the coaches, team representatives, other organizational representatives, and other parents on my child's team for use in all communications which are BWBBC related.
- I give permission for my child's picture to be used for promotional and educational purposes in BWBBC literature including, but not limited to, the BWBBC web page, newspaper articles, promotional flyers and brochures.
- I have read and agree to comply with all requirements and rules for the 2007 travel baseball season. I also agree that these rules must apply to all members with little or no exception in order for the organization to be successful. I understand that non-compliance with these regulations can result in my child's probation, suspension, or dismissal from the team.
- I understand that any pre-planned extended absences which fall outside BWBBC scheduled break periods must be communicated in writing to the head coach upon the acceptance of my child's position to a team. I further understand that failure to do so at that time will mean the stated attendance policy will apply without exception.
- I understand that email is the primary communication format used by BWBBC to keep me informed and updated regarding team events. I understand that it is my responsibility to be informed and check my email frequently. I also agree to advise my child's coach and team representative if I do not have access to email so they can use a different form of communication to inform me of last minute changes.
- I will regularly check the website at www.blackwidowsbaseball.com for current information and updates.
